- (c) whether it is a fact that they have rejected the reference to the Supreme Court under Article 143(i) on a historical issue; and
- (d) how does Government propose to deal with the matter?

THE MINISTER OF HOME AFFAIRS (SHRI S. B. CHAVAN): (a) of (d) The Babri Masjid Movement Coordination Committee had rejected the acquisition of land through the Ordinance and the Presidential Reference to the Supreme Court under article 143(i) of the Constitution. The Government have almounced that the acquired area excluding the area on which the disputed structure stood, would be made availa-

ble to two Trusts, which would be set up for the construction of a Ram Temple and a Mosque respectively and for planned development of the area. In the Presidential Reference it has been made clear that the Government proposes to settle the Ram Janam Bhoomi Babri Masjid dispute after obtaining the opinion of the Supreme Court and in terms of the said opinion.
