THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. M. SAYEED): Yes, Sir.

(b) and (c) A crowd had gather ed near the house of the gunman, of the Senior Superintendent Police, Chandigarh where a firing incident had taken place at about 10.30 PM on 17.10.92. The Chandigarh Police, while clearing the crowd, had forcibly overpowered a person, who later turned out to be a Lt. Col. Vats and detained him in the police station till the morning of 18th October, 1992. The Chandigarh Administration got the matter inquired into by a 'two Member Committee. Based on the findings contained in the reports, departmental action has been initiated against the Senior Sup-, erintemdent of Police). Besides, the Senior Superintendent of Police has been repatriated to his parent cadre from UT, Chandigarh and his services have been placed at the disposal of the Government of Punjab.
