(b) Letters of Intent are issued to the allottees by the four oil marketing companies namely, IOC, HPC, BPC & IBP.

Import of natural gas from OPESC

2820. SHR1 KRISHNA KUMAR BIRLA: Will the Minister of PETRO-LEUM AND NATURAL GAS be pleased to state:

- (a) whether the Tata Energy Research Institute have conducted a Study concerning energy trade possibilities between countries of South Asian Region and OPEC for mutual benefits;
- (b) if so, what are prospects of India gaining energy advantage from the mutual agreements for using natural gas;
- (c) whether Government propose to import natural gas from OPEC by laying pipeline either under sea or over ground:

SATISH SHARMA): (a) and (b) The Study conducted by TERI generally brings out the prospects of gas exports from the middle-East to South Asian countries, but specific details are not available for establishing the viability of gas imports into India.

(c) to (e) A proposal for the import of natural gas through a pipeline from the Middle East is at a conceptual stage.

Revised Oil Budget

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (CAPT. SATISH SHARMA): (a) and (b) Oil imports for the year 1992-93 is estimated to cost approximately 6.18 billion US dollars.

- (c) Planned indigenous crude oil production during 1992-93 was 28.464 MMT as against the expected production of 26.834 MMT.
- (d) This would depend upon the prices in international marke's along with the rugee value in the context of convertibility.
