For implementation of these programmes financial assistance in the form of grant and loan for various schemes under khadi and village industries is provided as per the pattern of financial assistance framed by thr KVIC KVIC has also formed liberalised pattern of assistance for hill, border tribal and weaker sections areas. The said pattern of assistance is applicable in the country including Uttar Pradesh State.

The new schemes proposed for development by KVIC in U.P. are as indicated below:—

- (i) Special programme in Nainital and Almora district.
- (ii) Special programme in Mau and Ghajipur district.
- (iii) Direct financial assistance by KVIC to 569 institutions to promote khadi.
- (iv) Introduction of recently dtveloped 8 Spindle Charkhas and installation of Combing Machine.
