3190. SHRI ANANT RAM JAISWAL: Will the Minister of MINES be pleased to state:

- (a) whether it is a fact that TISCO's 20 year lease of about 1261 hectares of chro-mite bearing land in Sukinda Valley in Orissa has expired and the renewal of the same is under the active consideration of Government;
- (b) what is the estimated Chromite reserves in the above mentioned area and what is the annual production need of Chromite by TISCO;
- (c) how much extraction of chrome ore is being done by TISCO.per annum from the area and how much of it has been sold by them separately both in the domestic and international market and income accruing therefrom; and
- (d) what is the earning on account of mining revenue and royalty separtely from this area?

THE MINISTER OF STATE OF THE MINISTRY OF MINES (SHRI BALRAM SINGH YADAV): (a) Yes, Sir.

(b) and (c) The Government of Orissa have reported an estimated Chromite ore reserves of 93.4 million tonnes in the Sukinda Valley Chromite mine of TISCO. The details of production of Chromite ore, its domestic consumption and export by the company during the last three years is as follows:—

- (a) whether the mica industry in Bihar *is* facing crisis and a number of units engaged in this industry are on the verge of closure;

THE MINISTER OF STATE OF THE MINISTRY OF MINES (SHRI BALRAM SINGH YADAV): (a) There has been a decline in the production of mica in Bihar.

- (b) Technological changes, use of mica substitutes and consequent low demand are the main reasons for the problems facing the mica industry.
- (c) Promotion of value added mica based products, research to identify new uses for mica products, and export promotion measures have been undertaken to help the industry.
