It is the responsibility of the State Government/local body to provide adequate safe drinking water to the people in urban areas including metropolitan cities.

to Questions

Due to rapid urbanisation and scarcity of raw water on account of depletion of ground water sources and lack of nearby surface water resources, the demand for drinking water as well as the cost for providing the same is increasing.

The Ministry of Urban Development has drawn the attention of the State Governments to the need for making the sector selfsustaining by cost recovery through user charges and conferring grea'er autonomy to the corporations/municipalities in the matter of fixation tariffs.

Fire in Udyog Bhavan, New Delhi

(a) the extent of damage caused by fire which took place in Udyog Bhavan, New Delhi on 4th March, 1993;

(b) what are the reasons therefor ;

(c) the names of high-rise buildings owned by Government and private concerns in Delhi for which fire clearance certificate have not so far been obtained and the raesons therefor; and

(d) what action Government have taken or propose to take against the defaulters?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT WITH ADDITIONAL CHARGE OF THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRI P. K. THUNGON- : (a) Office records, furniture, electrica" fittings, false ceiling etc. are reported to have been damaged due to fire on the 4th and 5th floors in Udyog Bbawan.

(b) The Committee constituted by CPWD to enquire into the fire in Udyog Bhawan has not been able to pinpoint the specific cause of fire.

(c) A list of unsafe government and pri vate high-rise buildings is given in the state ment attached (See below). Fire clearance certificate are issued by the Delhi Fire Ser vice on completion of all fire safety related measures in the high rise buildings.

(d) The Delhi Fire Service had issued notices to occupiers of unsafe government and private buildings deficient in fire safety

provisions in September 1993. Many hign-rise buildings have shown considerable progress in providing the fire safety requirements.
