

THE DEPUTY MINISTER OF THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE (KUMARI SELJA) : (a) to (c) The Centrally Sponsored Scheme, 'Improvement of Science Education in Schools', does not envisage introduction of special programme in States/UTs. Under the Scheme, financial assistance is provided¹ to States/UTs as and when suitable projects in this behalf, formulated in accordance with the norms of the scheme, are received from them.

During the last two years, viz., 1990-91 and 1991-92, a sum of Rs. 2,26,21,200/- was sanctioned to the State Government of Andhra Pradesh for the following items :—

- (i) Setting up of a new laboratories in 134 secondary schools,
- (ii) Upgradation of deficient science laboratories in 105 junior colleges and 129 secondary schools.
- (in) Supply of science books to 105 junior colleges and 263 secondary schools.
- (iv) Setting up of 13 District Resource Centres.
- (v) Training of science and mathematics teachers :
 - 9 orientation programmes for key persons/resource persons as also 11 workshops for development of guidelines, syllabi, instructional material etc.
 - 18 programmes for training of upper primary and secondary teachers.

THE DEPUTY MINISTER OF THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELIA) : (a) Ministry of Welfare has a centrally sponsored scheme "Research and Training" to provide funds to State Government on 50 : 50 basis to Tribal Research Institutes. These institutions have various activities excluding the preservation of Tribal Art and Culture, to ensure that there is no degradation of Tribal Culture and Art.

(b) An amount of Rs. 30.00 lakhs has been allocated in the Department of Culture to carry out the work of preservation and promotion of the tribal culture and heritage during 1992-93. Out of this an amount of Rs. 14.94 lakhs has been spent so far.

Apart from this a sum of Rs. 104.00 lakhs out of the budget provision of Rs. 105.00 lakhs has so far been released by the Ministry of Welfare.

(c) and (d) The projects are evaluated from time to time.
