#### **Setting up of Ship-breaking Yard at Haldia**

@3193. SHRI SUKOMAL SEN : Will (he Minister of STEEL be pleased to state

(a) whether Government have any proposal for setting up of a ship-breaking yard at Haldia in public sector or joint sector;

(b) whether of late there has been any discussion in this regard between Surface Transport Minister and the Minister of Transport of West Bengal; and

(c) whether it is a fact that the ship breaking capacity in India is much less than what is needed and a considerable amount of work for the country in this respect is done in foreign countries ?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV) : (a) and (b) There is no proposal before Government for setting up a ship breaking yard at Haldia in the public sector or joint sector.

(c) The quantity of ships broken during the present year is expected to be about one million tonnes which is substantially higher than the quantity broken last year. Quantity of ships broken in India is currently among the highest in the world.

#### **Perspective Plan for Steel Sector**

3194. SHRIMATI CHANDRIKA ABHINANDAN JAIN : Will the Minister of STEEL be pleased to refer to the reply to Unstarred Question No. 2516 given in the Rajya Sabha on the July 31, 1992 and state :

(a) whether the report of the Task Force set up for preparing an action plan for the growth of Indian Iron and Steel Industries over (he next 20 years has since been received by Government; and

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV) . (a) Yes, Sir.

(b) The report is under consideration of Government.

#### **Revamping of Ferro-ALloy Units**

Will the Minister of STEEL be pleased to state :

(a) whether Governments attention has been drawn to the International Conference on developments in ferro-alloy production;

(b) if so, whether it is a fact that the conference suggested revamping of existing ferro-alloy units and also that instead of exporting ores and minerals, high valued ferro-alloys be produced in the country to earn foreign exchange;

(c) if so, what are the other suggestions made in the conference;

(d) whether all the suggestions made in the conference have been considered by Government; and

(e) if so, the decision taken thereon?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV) : (a) Yes, Sir.

(b) to (c) While Government's policy is to encourage export of value added products like ferro alloys instead of export of ores like manganese and chrome, however, no communication has as yet been received by the Government regarding the suggestions made in the said Conference. From the press report on the Conference, as well as the Draft Report of the Technology Evaluation and Norms Study in ferro alloy industry published by Department of Scientific and Industrial Research, Ministry of Science and Technology, it is understood that most of the Indian Ferro Alloy plants do not incorporate latest technologies and there exists scope for revamping these plants so as to improve the plant perform

roance and operation.. As the ferro alloy industry "is de-licensed and most of the units are primarily in the private sector, it would be for the individual units to undertake various steps in improving their performance. Government nevertheless is responsive to the needs of the ferro alloy industry and would provide all possible support.

#### **Impact of Import of Scrap Steel**

3196. SHRI V. HANUMANTHA RAO : Will the Minister of STEEL be pleased to state :

(a) whether it is a fact that recent liberalised policies will adversely affect such Public Sector Units like Sponge Iron India Limited, Khammam District, Andhra Pradesh; and

(b) what steps are being taken to protect Public Sector Units using advanced technology and involved in import substitution ?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV) : (a) and (b) One of the objectives of the new industrial and trade policies is to make domestic industry including public sector units like Sponge Iron India Limited more competitive. It is a fact that due to the sharp fall in international prices of steel melting scrap (for which sponge iron is a partial substitute) the domestic sponge iron industry was facing difficulty. However, the international prices of scrap have now increased. The budget proposals for 1993-94 also contain various measures for improving the viability of industrial projects including sponge iron projects such as reduction of customs duty on capital goods, reduction of minimum interest rate on commercial advances, etc.

#### **Expansion Of Visakhapatnam Steel Plant**

3197. SHRIMATI KAMLA SINHA : Will the Minister of STEEL be pleased to state :

(a) whether it is a fact that the cost of the expansion of Visakhapatnam Steel Plant has increased further; and

(b) if so, what remedial steps have been taken in this regard ?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV) : (a) and (b) The Visakhapatnam Steel Plant with an annual capacity of 3 million tonnes of crude steel has been commissioned in July, 1992. The cost on completion of the project is estimated at Rs. 8529 crores. There is no proposal at present to expand the capacity of the steel plant.

#### **All India Induction Furnaces Association**

3198. SHRIMATI KAMLA SINHA :

Will the Minister of STEEL be pleased to state :

(a) whether Government are aware of the crisis/problems in the induction furnaces sector of the secondary steel making units; and

(b) if so, what remedial steps Government have taken in this regard; and

(c) whether the recommendations of the All-India Induction Furnaces Association have been considered by Government ?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI SONTOSH MOHAN DEV) : (a) and (b) There has been a general sluggishness in demand for steel due to various reasons. With the excise duty relief for steel user industries like automobile and capital goods contained in the budget proposals for 1993-94, demand for steel is likely to pick up. Reduction of minimum interest rate on commercial advances will also reduce the cost of production.

(c) Yes, Sir.
