Edible oil for Orissa

- *362. SHRI SANTOSH KUMAR
 SAHU: Will the Minister of
 CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION
 be pleased to state:
- (a) whether Government are aware of the shortage and higher prices of edible oil in Orissa;
- (b) whether the State Government has placed any demand before the Central Government for allocation of imported edible oil; and
- (c) if so, what is the State's monthly demand and allocation of edible oil made during the years 1992-93 and 1993-94?

THE MINISTER OF CIVIL SUPPLIES, CONSUMER AFFAIRS & PUBLIC DISTRIBUTION (SHRI A. K. ANTONY): (a) to (c) No report of shortage and/or rise in prices of edible oils has been received from Orissa. State Government of Orissa had last asked for allocation of edible oil in November, 1991 indicating that they would require the allocation till such time as prices of oils came down to reasonable levels.

State Government were accordingly allocated 5,500 MTs. of oil between November, 1991 and April, 1992 which they lifted by June, 1992. State Government neither made any demand nor were they allocated any oil thereafter as the prices of edible oils started declining from February, 1992.

Consumer movement in the country

(a) whether Government propose to involved N.G.Ds to strengthen the consumer movement in the country and also to ex-

pand its coverage in distributive trade;

(b) if so, what are the details thereof?

THE MINISTER OF CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI A. K. ANTONY): (a) & (b) The policy of the Govt. is to encourage involvement of NGDs in strengthening the consumer movement in the country. Enactment and enforcement of the Consumer Protection Act, 1986 itself is an important step in promoting a strong and broad based consumer movement in the country, under which voluntary consumer associations have been empowered to file complaints in the redressal agencies set up under the Act. They have also been given representation in various Councils/Committees and are being given financial assistance and support in their activities. So far as the coverage of distributive trade is concerned, the Act applies to all defective goods, deficient services, unfair trade practices in the public, private, joint and co-operative sectors. Only goods purchased for commercial or resale purposes are outside the purview of the Act.
