Review of the policy of liberalised economy

*10. SHRI M. A. BABY: Will the Minister of FINANCE be pleased to state:

- (a) whether eminent economists con sider that liberalisation of the economy has begun to manifest in the form of steep rise in unemployment in the country; and
- (b) if so, whether Government would review the said policy in consultation with those economists?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE AND MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (DR. ABRAR AHMED): (a) Economists have expressed divergent views on the effects of the policy of liberalisation on the economy. While some eocnomists have expressed the view that liberalisation would result in a steep rise in unemployment, others are of the considered opinion that this would result in a faster growth of the

economy, and of employment, in the long run. As there is no firm statistical evidence of any perceptible rise in unemployment, besides the usual historical one, the view of some economists as to a steep rise in unemployment after liberalisation could only be the result of their perception of the effects of liberalisation, on the economy in general and on the employment situation in particular.

(b) The Government have repeatedly made it clear that liberalisation of the economy would not result in any signi-cant rise in unemployment as no retrenchment of existing employees would be permitted as a result of Economic Policy, though the New redeployment of the work force may take place in order to meet the requirements of modernisation and restructuring. The Government have already operationalised the National Renewal Fund to provide assistance for retraining and redeployment of workers as also to provide a social security net to the labour force. Even so. the option of consultations with economists and other eminent citizens is always kept open by the Government in order to correct any adverse effects of the policies.

Assistance for development of Tourism in Karnataka

- (a) what is the rationale behind providing financial assistance to States for development for tourism projects;
- (b) whether this has been adhered to in regard to the meagre allocation to Karnataka tourism projects all these years; and
- (c) whether Government would consider the infrastructural facilities already available in Karnataka, besides further scope for development of tourism, and sanction crash projects to tap the foreign exchange earning potential to its fullest extent?
