(c) and (d) Reserve Bank of India are of the view that they do not envisage that the decision to open new banks in private sector will affect the viability of the existing public sector bunks.

### Guidelines for private sector banks

- (c) and (d) Reserve Bank of India have reported that private sector banks are subject to their inspections once in every two years. During such inspections of private sector banksi, RBI monitor observances of guidelines issued toi them. RBI conveys main findings of their inspection alongwith, full report to the chief executives of the bank concerned. The findings are also discussed

by the RBI with bank management for taking necessary remedial measures.

However, administrative, legal and other measures as are considered necessary, have been taken from time to time, but no specific dead line has been set for recovery.
