Gap between the requirement and avail* ability of Blood

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND1 : (a) and (b) Yes. Sir. As against the Annual estimated requirement of 40 lakhs units of blood in the country the availability is only 19.5 lakh units.

(c) The National AIDS Control Programme contains a comprehensive plan for augmenting the availability of blood and Mood products by promoting voluntary donation of blood as a popular movement and by encouraging rational and efficient use of blood by education of medical practitioners and setting up of component separation facilities in 30 identified centre*.

Training to Medical Staff for Rural Health in Bihar

SHAN-KARANAND) : (a) to (c) Training of grassroot level workers and para-medical staff is an integral part of delivery of health care. 33 Auxiliary Nurse Mid-Wife Training Schools and 2 Lady Health Visitors Training Schools are functioning in the State to provide basic training. Four Health & Family Welfare Training Centres set up in the State Provide in-service training to health personnel. Effective utilisation of these facilities can meet the training requirements in the State.
