

(c) whether adequate monitoring for satisfactory performance of Command Area Development projects is done by the Union Government before the Central funds are given every year for such projects; and

(d) if so, the details thereof ?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT WITH ADDITIONAL CHARGE OF THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRI P. K. THUNGON): (a) and (b) A total of 164 CAD Projects are presently being funded under the Central Sector. An outlay of Rs. 830 crores has been provided for the CAD programme in the Central Sector under the Eighth Five Year Plan. Allocation of funds from the Central Sector to State Governments for execution of Projects depends on demand received from the States for allocation of funds for CAD projects and availability of funds with the Central Government. As such no advance project-wise/State-wise allocation of funds is made.

Additional Irrigated area to be covered under the project would depend on utilisation of funds by the State Government based on projects for which reimbursement is claimed.

(c) and (d) Central Assistance under the CAD programme is released after scrutiny of physical and financial progress of work undertaken by the State Governments according to the prescribed norms.

Clearance of major and medium Irrigation Projects in Andhra Pradesh

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT WITH ADDITIONAL CHARGE OF THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRI P. K. THUNGON): While, no irrigation project of Andhra Pradesh has been given clearance by the Central Government in the current year, 3 medium projects of Andhra Pradesh namely Maddileru, Yerrakalva and Kaulasala were appraised in Central Water Commission and found acceptable by the Advisory Committee in its meeting held in December, 1992.

(c) Many areas of Eastern region are reported to be affected by water logging out of which about 9 lakh hectares of land are in Bihar.

(d) Yes, Sir.

(e) An integrated drainage project has been undertaken by the Government of Bihar for removal of water logging. For this purpose, Rs. 7 crores in Annual Plan '93-'94 and Rs. 50 crores in Eighth Plan (1992-97) have been proposed by the Government of Bihar.
