CON SUMER AFFAIRS AND PUBLIC DIS TRIBUTION WITH **ADDITIONAL** CHRGE OF THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KAMALUDDIN AHMED) : (a) to (f) Agricultural exports offer an ex panded market to the farmer and therefore a higher price realisation. Government has taken various steps to create an en vironment which is favourable to exports, including export of agricultural products and processed foods from the country. Such measures include the exchange rate adjustments, the introduction of a unified exchange rate, the expansion of the defi nition of 'manufacture' in the EXIM Policy, to include agricultural and allied activities, simplification in compulsory preshipment inspection procedures, lowering custom duties on capital goods and inputs, and the assured avaiabhility of export credit on softer terms.

The targets for exports of agricultural items during 1992-93 is US \$ 2000 million. Europe, USA and West Asia are the major markets for India's agricultural commodities.

The quantities of sugar exported during 1991-92 and 1992-93 (1-4-1992 to 22-3-1993) arc given below :—
