THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI SUKH RAM): (a) to (d) The required information is being collected.

(e) and (i) Service connections are sanctioned by competent authorities purely in the interest of service. Service telephones are also provided as a part of an agreement with the Service Unions.

Lowering of charges for money orders

- 3951. SHRI V. HANUMANTHA RAO: Will the Minister of COMMUNICATIONS be pleaed to state:
- (a) whether Government are aware of the problems of poorer and lower income groups who have to pay increasingly higher money order charges;
- (b) whether better technology, telex and fax have not actually reduced the costs of transmitting and delivering money orders; and
- (c) steps being taken to pass on the benefits of technology and lower costs to the public?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI SUKH RAM): (a) M.O. commission is charged at the rate of Re. one for every sum of Rs. 20/- or fraction thereof. There has been no change in the rate after June 1990. Having regard to the fact that Money Orders are paid at the door of the payee even in the remote villages, together with the written communication of the remitter and acknowledgement of the payee furnished to the remitter, it cannot be said that the charges are high even for the lower income groups.

(b) and (c) At present, Money Orders are transmitted as any other postal article and no technology is utilised. While transmission of Money Orders by technologically advanced

means may result in reduction of operational costs of the Department, the scheme for transmission of money orders in certain areas of the country through satellite which has been approved by Government is still in the process of implementation. It in too early at this stage to consider its implecatiojis in terms of commission charged on Money Orders.

- (b) Investigation into the comp laints of misuse of STD facility rev eal that misuse can be within the ex change or at the subscribers' premises or outside the Exchange in the exter nal plant.
- (c) Surprise inspections by the vig ilance and supervisory staff have been intensified.
