SALVE): (a) to (d) The power from Central Generating Stations is distributed among various States, The allocation of power from the Central Generating Stations is made to the States on the basis of the formulae approved, Various States have been representing from time

to time for revision of the formulae so as to increase their share in the power allocated to them from the Central Generating Stations. The present formulae have been in force for quite sometime and by and large the States have found them acceptable. There is, at present, proposal to revise the formulae.

THE MINISTER OF POWER (SHRI N. K. P. SALVE); (a) t_0 (d) The Government is aware that national convention of Institution of Engineers was held on the 29th and 30th January, 1993 in New Delhi, where anticipated power shortage by the end of the VIII Five Year Plan was also considered. The Govern_ ment is also aware that un completion of the capacity addition prog. ramme of 30537.7 MW during the VIII Plan, the anticipated supply position in the terminal year of the plan viz. 1996-97 will be as follows:-
