विशः मंत्रालय में राज्य मंत्री (श्री एम०वी० चन्द्रशेखर मूर्ति): (क) श्रीर (ख) श्रपवंचन-रोधी महानिदेशालय, केन्द्रीय उत्पाद शुल्क, नई दिल्ली की उत्तर प्रदेश में सीमेंट एककों द्वारा केन्द्रीय उत्पाद शुल्क का श्रपवंचन किये जाने के संबंध में कोई विशिष्टि श्रासूचना प्राप्त नहीं हुई । श्रतः श्रपवंचन-रोधी महानिदे-शालय द्वारा उत्तर प्रदेश में सीमेंट एककों के विरुद्ध केन्द्रीय उत्पाद शुल्क श्रपवंचन के किसी मामले का पता नहीं लगाया गया है।

Money deposited in foreign banks

4007. SHRI ISH DUTT YADAV: Will the Minister of FINANCE be pleased to state;

- (a) whether Government are aware that some Indians have their money deposited in the Swiss Banks;
- (b) it so, what is Government's estimate with regard to the quantum of deposited amount in the said Banks;
- (c) whether there are Government's rules with regard with deposit of money in the Banks situated abroad; and
- (d) i! not, what action has been taken by Government against those depositors who have deposited their money in the Swiss Bank?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE

- (SHRI M. V. CHANDRASHEKHAR MURTHY); (a) Yes, Sir.
- (b) and (c) FERA, 73 prohibits resident Indians from maintaining accounts in a Bank abroad except with the permission of RBI. No estimate is possible when deposits are made clandestinely.
- (d) As and when such an instance comes to the notice, the Directorate of Enforcement takes appropriate action (including penalty, prosecution) under the provisions of FERA.

Curbing inflation

4008. SHRI H. HANUMANTHAPPA: Will the Minister of FINANCE be pleased to state:

- (a) what is the present rate of inflation; and
- (b) what steps have been taken to bring it down?

THE MINISTER OF STATE THE MUNISTRY OF FINANCE AND MINISTER STATE IN OF THE MINISTRY OF PARLIAMENTARY AFFAIRS (DR. ABRAR AHMED): (a) The rate of inflation based on wholesale Price Indices as 13*t*h March, 1993 was 6.8 per cent.

(b) Government have taken several steps both on the demand and supply sides to keep prices under check. These include strict control on fiscal deficit, a tight monetary policy, reduction in customs and excise duties and augmentation of domestic supplies through timely imports of essential commodities.
