THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) Government have statistics only pertaining to pilgrims and nationals engaged in border trade. The number of pilgrims to Kailsh and Mansa-rovar in Tibet for pilgrimage in 1992 was 233 and the number of traders who went to Tibet for border trade in the same period was 299.

- (b) Some pilgrims have reported that they have faced difficulties in transportation and boarding and lodging in Tibet, which ere not matters under our control.
- (c) Indian pilgrims travelling for the Kailash-Mansarover yatra are issued Chinese visas by the Chinese Embassy in Delhi, while those crossing the India-China border for border trade at Lipulekh Pass do so on a special Travel Pass issued by the Pithoragarh, UP district authorities,
- (d) Government does not discourage travel to Tibet.

No flag hoisting on Republic Day by Indian **Embassy in Sudan**

Indo-pak bilateral relations after bomb explosion in Bombay and Calcutta

4131. SHRI MOHINDER SINGH LATHER:

SHRI RAM GOPAL YADAV: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Pakistan's hand has beer found either directly or in-directly in recent bomb explosion in Bombay and in Calcutta and day by day incidents of bomb blasts in both these cities;
- (b) if so, the reaction of Government stating its clear stand on the matter/incidents;
- (c) its impact on Indo-Pak bila-t ral relations as well as on Indian people?

THE MINISTER OF **EXTERNAL** AFFAIRS (SHRI DINESH SINGH): (a) Six persons wanted by the investigating authorities in the Bombay explosions case are known to have proceeded from UAE to Karachi on March 17, 1993.

- (b) The Pakistan Government have been requested to cooperate in lecaiing, apprehending and returning the suspects to India.
- (c) Impact on Indo-Pak relations will depend on Pakistan's response.

- THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) and (b) Government have seen press reports on Pakistan Prime Minister's interview to CNN on 29-1-1993 where he has, *inter-alia*, stated that it is true that Pakistan has acquired nucleiar capability.
- (c) Government constantly monitor all developments having a bearing on India's security and take nec; ssary measures to safeguard it.
- (d) Our concern over the pursuit of a clandestine and weapons oriented programme and its implications for India's and regional security and sta bility have been conveyed to all concerned.

In do US relations in post cold-water Period

- 4133. DR. NAUNIHAL SINGH: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether Government are aware that the new American Administration has a focus on Nuclear Proliferation and human rights issue;

- (c) whether Government are aware of study report of the RAND Corpo ration on Indian strategic thinking as sponsored by US Administration, if so, the details thereof:

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) Yes, Sir.

- (b) Government are discussing is sues relating to disarmament, nuclear non-proliferiation and regional security bilaterally with the US Government. Our position on human rights and measures taken by Government to uphold human rights have also been communicated to the US Government.
- (c) Yes, Sir. The US Department of Defence commissioned a study by the RAND Corporation on India's strategic thought. This study, authored by Dr. George Tanham, contends that there is an absence of strategic thinking and planning in India, stem ming largely from India's historical and cultural development which has led to the development of a predominantly defensive strategic orientation.
- (d) Yes, Sir. The Carnegie Endow ment for International Peace's report on"India and America after the Cold observes that the end of the Cold War has created the opportunity for a significant improvement in rela tions between the United States and India and offers a range of policy re commendations to both governments overcome current irritants deepen bilateral ties. Inter alia, these recommendations cover the areas of defence cooperation, nuclear restraint, missile development, economic reforms, human rights, narcotics control, Indo-Pak relations, India-China relations and the restructuring of the United Nations Security Concil.
