- (a) whether it is a fact that D.T.C has stopped plying bus No. 723 from Sagarpur School Block to Kendriya Terminal;
- (b) whether it is also a fact that the S.T.A. bus meant for this route starts from Manglapuri and takes Palam road to reach Kendriya Terminal:
- (c) if so, whether Government are aware of the difficulties faced by the residents of Sagarpur in reaching schools and offices; and
- (d) if so, what remedial steps are being taken in this direction?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYT-LER): (a) Yes, Sir

- (b) Yes Sir.
- (c) and (d) The route no. 723 was operating between Sagarpur to Kendriya Terminal with a schedule of only one DTC bus. This duty was heldup due to reduction in the DTC's fleet on account of resource constraints. The residents of Sagarpur can avail the services of route no 730

from Pankha Road which is directly linking to Kendriya Terminal. Regarding Red line buses, the Govt. of National Capital Territory of Delhi have entrusted to the RITES a study on finalisation of routes.
