Reported speech of Railway Minister at the manguration of Shatabdi Express In Mysore

SHRI MISA R. GANESAN (Tamil Nadu): Madam Vice-Chairperson, my special mention is in respect of the unwarranted uncalled for, unnecessary and out of place speech made by the Union Railway Minister, Mr. C. K. Jaffer Sharief on the 9th of this month in Mysore when he inaugurated the Shatohdi Express. Madams.; it is very unfortunate that unnecessarily, at the fag-end' of his speech, he made a remark which hurts the feelings and sentiments of the people of the entire Tamil Nadu. He has stated:

"Madras wants Cauvery to flow towards it. So. I have made Madras come to Cauvery and drink Cauvery water to its heart's content and return."

This is the remark made by him at the insuguration of the Shatabdi Express between Madras and Mysore. It is un-warranted unnecessary and out of place.

SHRIMATI JAYANTHI NATARA-JAN (Tamil Nadu): It is very unfortunate.

SHRI MISA R. GANESAN: The problem of Cauvery is a problem, of life and death for the people of Tamil Nadu; not just the people of two districts, Thanjavur and Trichy, but of the entire Tamil Nadu.

SHRI JOHN F. FERNANDES (Go.:): It is denied by the Minister.

SHRI MISA R. GANESAN: He may say that he has stated it in a lighter vein or in humour. At the cost of the sentiments of the people of Tamil Nadu. the Minister has no business to comment like this even in a lighter vein. (*Interruptions*).

Yesterday, when I tried to raise this matter in the Zero Hour, our hon. Deputy Chairman did not permit me. She said that she would call for the Minister and he would come and give some explanation. He came yesterday to the House. But before the Zero Hour, he went away. However, he has given a reply to the hon. Chairman in writing. I quote the reply:

"During the function of inaugurating the Shatabdi from Mysore to Madras *via* Bangalore. I said that Tamil Nadu is keen on Cauvery water. Sometimes Madras goes without drinking water. We, the Railways, carry drinking water. Now With this Shatabdi, people who come from Madras to Mysore as tourists can drink plenty of Cauvery water to quench their thirst. Nothing more than this. This was in humour."

Madam, he should not have said this even in humour. While inaugurating the Shatabdi Express, he had no business to make humour at the cost of the people of Tamil Nadu. It is highly unwarranted. How is the Prime Minister having such a Minister in his Cabinet? The Minister comes from Mysore. He should have minded his language and should not have ventured to have humour by hurting the feelings of the people of the neighbouring State of Tamil Nadu. Ma-

dam, is this a matter for humour? He should come to the House and apologise for this. Or, he should resign.

SHRIMATI JAYANTHI NATARA-JAN: Madam, I want to associate myself with what Mr. Ganesan said. The hon. Union Minister's remarks in this regard are extremely unfortunate and are in very bad taste. Cauvery is a problem of life and death for Tamil Nadu. If the Members of the Union Cabinet are going to treat it as a joke, I am sorry, the people of the State of Tamil Nadu are feeling badly hurt. Cauvery is no joke for us. It is a matter of life and death for the people! of Tamil Nadu. I condemn the remark"! of the hon. Minister.

SHRI MISA R. GANESAN: He is always making critical remarks. (*Interruptions*).
