Abolishing of sitting accommodation in Trains

1229. SHRI KRISHAN LAL SHARMA : Will the Minister of RAILWAYS be pleased, to refer to the answer to Unstarred Question 384 given in the Rajya Sabha on 28th July, 1993; and state :

(a) whether it is a fact that Railways have altogether abolished the provision of reservation of sitting accommodation even for day journey on long distance trains and superfast trains ;

(b) whether it is also a fact that Government propose to review this decision in view of providing accommodation to more passengers; and

(c) if so, by when a final decision is likely to be taken in this matter and if not, what are the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI K. C. LENKA) : (a) The facility of reservation of sitting accommodation during day-journey on long distance and superfast trains, in different classes, exists subject to availability of accommodation.

(b) and (c) Do not arise.

(d) what are the other trains in which this facility would be made available in future and by when ?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI K. C. LENKA) : (a) to (d) Yes, Sir. Initially an A.C 3-Tier Sleeper has been provided on 2951 /2952 Rajdhani Express in place of an A.C. Chair Car. Depending upon availability, A.C. Chair Cars in all the Rajdhani Expresses are proposed to be replaced by A. C. 3-tier coaches.
