Extension of Broad Gauge Railway Line from Jogigopa to Mizoram

THE MINISTER OF RAILWAYS (SHRI C. K. JAFFER SHA-RIEF): (a)and(b) Some representations have been received from Members of Parliament and State Government for construction of a new BG line from Jogigopa to Silchar.

- (c) Yes, Sir.
- (d) A survey for a new BG line from Jogigopa Bridge to Silchar (approximately 200 kms.) has been included in the Rilway Budget for 1994-95.

Modernisation of Railway Telecom Network

5778. SHRI SURESH KAL-MADI: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that the Indian Railways have decided to modernise its telecom network along the electrified routes;
- (b) if so, what are the details of the proposed modernisation; and
- (c) by when entire work is likely to be completed?

THE MINISTER OF RAILWAYS (SHRI C. K. JAFFER SHA-RIEF): (a) Yes, Sir.

(b)and(c) Indian Railways modernising its telecom, network along the electrified routes. Overhead

telecom, circuits are transferred on to the more reliable underground cable system. This also enables provision of additional telecom. circuits. Railway Electrification is a continuous process and the present work load is likely to be completed by March, 98, subject to availability of resources.

Interaction for tetter railway ser-vices

- (a) whether it is a fact that the Chairman, Railway Board has urged for better interaction between the road and railway transporters to provide better and more efficient services to the people;

THE MINISTER OF RAILWAYS (SHRI C. K. JAFFER SHA-RIEF): (a)and (b) An International seminar was organised under the aegis of International Union of Railways at New Delhi in Jan. '94. The main theme was "Importance of the Railways in the National Economy" During this Seminar , Chairman, Railway Board in his keynote address called for better interaction between Road and Rail transport to improve efficiency, customer service and optimise asset utilisation as some of the strategies.

(c) Discussions at this International Seminar foeussed on the importance of Railways in the economy of nations. Various strategies for imporving the performance of the Rail-ways were discussed. Cooperation
