THE MINISTER OF STATE IN THE DEPARTMENT OF PERSONNEL AND TRAINING OF THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRIMATI VASUNDHARA RAJE): (a) The Public Enterprises Selection Board (PESB) has been set up in order to evolve a sound managerial personnel policy for Public Sector Enterprises and also to advise the Government on appointments to the top management posts.

- (b) A comprehensive review of the PESB was made in the year 1987 and the policy relating to the functions, membership, methodology for selection and infrastructure of the Board was revised and notified vide DOPPs Resolution dated 3rd March, 1987.
  - (c) No, Sir.
  - (d) and (e) Do not arise in view of the reply to part (c).

(e) in what manner Government propose to rationalize the inter-se placement of DRs and promotees in this service in the light of DOPT's instructions?

THE MINISTER OF STATEIN THE DEPARTMENT OF PERSONNEL ANDTRAININGOFTHEMINISTRYOFPERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRIMATI VASUNDHARA RAJE): (a) The objective of the instructions contained in Department of Personnel & Training O.M. 35014/2/80-Estt. (D) dated the 7th February, 1986 is to dispense with the practice of keeping vacant slots for being filled up by direct recruits of later years, thereby giving them unintended seniority over promotees, who are already in position.

- (b) The instructions contained in the said O.M. are applicable to all Central Services subject to the provisions contained in the relevant statutory Service Rules. The responsibility for the implementation of these instructions rests primarily with the Cadre Controlling Authorities and information in this regard is not monitored centrally.
- (c) and (d) A notification amending the CSS Rules, 1962 had been issued on 29.12.1984 which broadly covers the spirit of O.M. dated 7.2.1986.
- (e) Inter-se placement of direct recruit and promotee Section Officers of CSS has been done by issuing a Common Seniority List dated 03.12.1997 in pursuance of Supreme Court order dated 9.5.1997.

## Discouragement Policy for persons having more than two Children

- (a) whether Government are contemplating for not providing opportunities for Government jobs and promotion in service to the persons having more than two children on the lines of the Rajasthan Government;

There is no proposal at present to exclude people who have more than two children from securing a Government job or promotion.
