1985—AI Bombing Plot

(a) whether Government's attention has been drawn to report in the Indian Express of 3rd February, 1984 captioned '1985—AI Bombing plot—Americans knew, but kept mum' stating the A Canadian television has claimed that US—Intelligence agencies withheld significant information regarding their knowledge of the 1985—AI bombing plot in which 329 people were killed by extremists in league with Pakistani authorities; and

(b) if so, what was Government's response and reaction, if any, thereto, by way of inquiring into the aspect of US Complicity in the plot?

equity base and raising funds from the public and augmenting the resources of the Indian Airlines and Air India following their reorganisation as public limited companies;

(b) if so, the details thereof; and

(c) whether Government have also decided to expand and augment their activities to make them viable enough to meet competition from private airlines?

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI GULAM NABI AZAD): (a) and (b) The equity base of the Air India Limited and Indian Airlines Limited would need to be widened in future, by issue of fresh equity to meet growth requirements of the airlines. No decision has yet been taken in this regard.

(c) Competition from private operators is limited to the domestic sector and Indian Airlines has taken various steps to meet the challenge.
