- (c) if so, why these posts are lying va cant since such a long period;
- (d) whether there is any proposal to fill these posts on ad hoc basis; and
  - (e) if so, what is the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT DEPTT. OF EDUCATION & DEPTT. OF CULTURE; (KUMARI SELJA): (a) 10 (c) Nineteen posts of varoius categories are vacant for varying periods. The process of recruitment against 13 posts is at different stages. 2 posts have been held in abeyance and recruitment rules are being amended for 4 posts.

(d) and (e) Except one post for which the Hon'ble Tribunal has given directions, no other post is being filled on ad hoc basis:

- (b) and (c) Six posts are filled and five posts are lying vacant for varying periods. Action has been initiated for filling up two posts. Recruitment Rules for the other two posts are being amended. The remaining one post is lying vacant as its incumbent is presently on deputation.
- (d) Hundred per cent by promotion failing which by direct recruitment.
- (e) Only one post of Research Officer is lying vocant due to non availability of the reserved category candidate.
