(a) whether it is a fact that the Regional Offices of Kendriya Vidyalaya Sangathan are empowered to recruit teachers of almost all categories regionally through a selection cum interview method and that only those candidates are called for interview who have higher than cut off marks decided upon for the purpose;

(b) if so, what were the cut off marks decided upon by Patna Region for recruitment of teachers of different categories for selection for 1993-94;

(c) whether it is also a fact that many teachers who had less than cut off marks to their credit were also called for interviews in that session;

(d) if so, what are the details thereof as also the details of those who were ultimately selected for the post they were interviewed; and

(e) what was the justification therefor?

क्या मानव संसाधन विकास मंत्री यह बताने की कृपा करेंगे कि :

(क) प्रो० चट्टोपाध्याय आयोग की उन सिफारिशों का ब्योरा क्या है जिन्हें (i) बिना संशोधन के स्वीकार कर लिया गया है, (ii) संशोधन सहित स्वीकार किया गया है, और (iii) पूर्णतया अस्वीकार कर दिया गया है ;

मानव संसाधन विकास मंत्रालय (शिक्षा विभाग एवं संस्कृति विभाग) में उपमंत्री (कुमारी शैलजा) : (क) से (ग) चट्टोपाध्याय आयोग ने 1985 में अपनी रिपोर्ट प्रस्तुत की थी। इस रिपोर्ट में 138 सिफारिशों की गई थीं, जिसमें से अधिकांश सिफारिशें विस्तृत अध्ययन के अनुसार थीं। ये राष्ट्रीय स्तर पर एक मौखिक पाठ्यक्रम तैयार करने, व्यावसायीकरण, प्रारम्भिक शिक्षा को संवर्धित बनाने, शिक्षकों के स्तर, कार्य दशाओं तथा उनके कल्याण आदि से संबंधित थीं। सरकार राष्ट्रीय शिक्षा नीति तथा कार्य योजना (यथा संशोधित 1992) दोनों के निर्धारण में इन सिफारिशों पर पहले से ही ध्यान दे रही है तथा इस समय ने शिक्षकों से संशोधित वेतनमानों तथा उनकी परिलब्धियों को 1-1-1986 से अधिसूचना कर दी है। ऐसी स्थिति में इस समय अन्य राष्ट्रीय शिक्षक आयोग नियुक्त करने का कोई प्रस्ताव नहीं है।

Schemes for development of children

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF WOMEN AND CHILD DEVELOPMENT (SMT. BASAVA RAJESHWARI): (a) and (b) The Major Schemes undertaken by Government for the development of children in the country include Integrated Child Development Services including Adolescent Girls Schemes, Balwadi Nutrition Programme, Early Childhood Education and Creche/Day Care Centres for children of Working and ailing mothers as

well as scheme for the welfare of Street Children and Prevention and Control of Juvenile Maladjustment and Child labour. Recently, a National Creche Fund for Child Care Services has also been set up.

(c) In addition to services being provided for mother and child development under ICDS and other child care programmes mentioned above, the Child Survival and Safe Motherhood Programme has been launched with a view to check child mortality in the country.

Multi cultural centres in Punjab
