to the Government regarding the issues mentioned in the Jansatta news item dated 31-1-1994 after the Chief Ministers' Conference held in January. 1994, they have not briefed the press in this regard. The Minister for Internal Security did not visit Malda on 28.1.1994 at all.

The Chief Minister, West Bengal, had raised the issue that mixing of voters' card with identity card in infiltration-products will be duplicating the exercise, and it will not serve any useful purpose.

Payment of relief to Kashmiri Migrants in Ghaziabad

(b) According to available information in the case of 52 families residing in Tehsil Dadri, District Ghaziabad payments have not been made since different dates from June to December. 1992

- (c) whether it is a fact that the present Education Minister of Kerala, Shri E. T. Mohammad Basheer, is a Member of the Advisory Board under whose guidance the encyclopaedia was prepared; and
- (d) if the answer to the above pasts are in the affirmative, what action in the matter?
