- (c) As per the information received from the State Govt. Rs. 3.71 crores is allocated for medicines for primary health care. In addition, the Central Government provides medicines under the various National Programmes
- (d) A statement showing the State-wise allocations under Family Welfare Programmes, National Health Programmes, and under Minimum Needs Programme during 1993-94 is annexsed. (See Appendix 170, Annexure No 48) In the 5 demographically weak districts for upgradation of 5 PHCs each year in 1992-93 and 1993-94, Rs. 10,00 lakh per year have been provided.
