(b) whether it is a fact that due to lack of interest and negligence on the part of the present Head of Department, who is also the Head of Department of Skin, the number of patients as well as trainces from northern India are decreasing day by day;

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND): (a) The STD Department was started in. Safdarjung hospital in 1954. Since January 1991. Dermatology, Leprology and STD constitute one department and have one head.

#### Family Planning Programme in Rajasthan

(a) whether it is a fact that a significant number of eligible couples in the demographically critical state of Rajasthan is keen to practise contracaption but are unable to do so because of poor quality and inadequate follow up services;

(b) if so, whether the family planning programme in Rajasthan suffers from structural problems like over centralisation, absence of a marketing approach create demand, to and excessive medicalisation of the programme; and

(c) if so, what steps Government intend to take to make the family planning programme affective in Rajasthan and what are the details thereof?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND): (a) and (b) No, Sir.

(c) 100% Centrally-sponsored Family Welfare Scheme is under implementation in the State. An Action Plan is being operationalised by the State Government for promoting family planning. Under the World Bank assisted Social Safety Net Scheme, financial assistance has been provided to the State for demographically weak districts.

### AIDS Awareness Campaign Through NSS

6708. SHRIMATI VEENA VERMA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether the National AIDS Control Organisation (NACO) and the WHO have launched a major awareness campaign against AIDS through the National Service Scheme; and

(b) if so, what are the details of the

campaign programme?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND): (a) Yes Sir.

(b) A programme called "University Talk AIDS" has been launched in collaboration with WHO through N.S.S. network involving 59 universities initially. Thereafter the programme is being extended to all universities and colleges in the country. As a part of this, a training module for students, youths has been developed. In addition, a set of information. education and communication materials including films, songs, poster etc. has aiso been developed." level All university coordinantors have been trained. By the end of this year all college N.S.S. coordinantors and many peer educators will be trained.
