deplete the Ozone Layer, India intends phase out such substances accordance with provisions of the Protocol. A country Programme has been prepared to phase out ozone depleting substances in India, will be determined by the availability of financial resources and transfer of technology from the Multilateral Fund of the Protocol.

## Closing Down a Temple in Hartfordshire

6620. SHRI O.P. KOHLI: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether several thousand Hindus took a protest march against the decision to close down a temple in Hartfordshire donated by the former Beatle George Harrison in 1973 as appeared in the newspapers of 18th March, 1994;
  - (b) if so, the facts thereof; and
- of Government (c) the reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SALMAN KHURSHEED): (a) Yes, Sir.

(b) and (c) The matter relates to the functioning of the Bhakti Vedanta Manor as a Hindu temple and its request to the local District Council for an access route to the Temple which would enable devotees to visit the Temple without disturbance to the residents of the area. It also relates to an enforcement order served on the Temple by the local District Council which took effect on March 16, 1994 under which the Bhakti Vedanta Manor would cease to function as a temple. Efforts to reach an amicable settlement in the matter are continuing. The Indian High Commission in London has been maintaining informal contacts with the various parties concerned to promote a satisfactory outcome of these efforts.

## Realisation of Compensation Amount from Bangladesh Government

- 6621. DR. B.B. DUTTA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether Government has realised the amount of compensation or part of it from the government of Bangladesh in lieu of compensation paid to Indian citizens migrated from Bangladesh before 1971: and
- (b) if so, the details thereof; and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SALMAN KHURSHEED): (a) No. Sir.

(b) Government took up with the Government of Bangladesh the question of compensation for properties belonging to Indian citizens who migrated from the erstwhile East Pakistan before 1971. Our concerns about an expeditious resolution of this issue were also conveyed to the Bangladesh authorities on several occasions. The position taken by the Government of Bangladesh is that the settlement of the auestion compensation for Indian nationals would have to await the final settlement of assets and liabilities between Bangladesh and Pakistan.
