(a) whether it is also a fact that high officials are not found accountable for this' accident if not What are the reasons therefor,?

THE MINISTER OF RAILWAYS (SHRI CK. JAFFER SHARIEF): (a) The General Rules of the Indian; Railways permit attaching of the tower wagon in section with other vehicles attached, tinder special instructions:

(c) and (d) A departmental Inquiry Committee was asked to inquire into this accident and based on their recommendations, suitable punishments have been awarded to the officials, found responsible for this accident.

THE MINISTER OF RAILWAYS (SHRI C. K. JAFFER SHARIEF) (a) and (b) Railways have an elaborate system of inspection of Railway bridges for assessing and "monitoring their condition and identifying need for repairs! The requisite repairs are carried cut timely and bridges are maintained in safe condition; The identified repair' works are, carried put by the Railways under their own powers,
