THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI MALLIKARJUN): (a) Yes, Sir.

(b) Only surplus, unserviceable and obsolete Air Force equipments/items are offered for disposal. Disposal is only through the Special Surplus Stores Disposal Committee set up by the Ministry of Defence. All the equipments/items, mentioned in the news-item for disposal, are obsolete and unserviceable and cannot be utilised further. All sales of such Defence equipment to other countries is regulated as per laid down policy of the Government.

Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that F-16 bombers are matched by MIG-29 fighter and the French Mirage-2000;

(b) what are the characteristics of the above planes, their combat or defence attributes, cost per plane, and efficiency;

(c) whether Pakistan and India have any of the above planes, if so, their numbers; and

(d) what is the defence mechanism against these planes?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI MALLIKARJUN): (a) to (d) Though, it is not possible to match an aircraft with

another on each attribute, F-16, MIG-29 and Mirage-2000 aircraft are fairly well matched in 'Air Defence' role. While F-16 and Mirage-2000 are multirole aircraft, MIG-29 is optimised for Air Defence Role. The price paid in 1989 for a MIG-29 aircraft was about Rs. 24 crores. For the Mirage-2000 aircraft, the price paid in 1988 was about Rs. 31 crores. Pakistan has F-16 aircraft in its inventory. The present Air Defence system comprises Radars, mobile observation flights, Surface to Air Guided weapons and interceptor aircraft. It will not be desirable to disclose the numbers in each type of aircraft held in the IAF inventory.
