Government land under occupation of Delhi Race Course Ctube

*6r72. SHRI SANJAY DALMIA: Will the Minister of URBAN DEVELOPMENT be pleased to state;

- (a) whether it is a fact that the Delhi Race Course Club has been occupying Government land on lease;
- (b) if so, at what rate, terms and conditions and what is the expiry date of the lease;
- (e) what i« the existing market rent for similar kind of land on lease and whether the same amount is being charged from Delhi Race Course Club; and
 - (d) if not, what are the reasons therefor?

THE MINISTER OF URBAN DEVELOPMENT (SMT. SHEILA KAUL): (a) Yes, Sir. The Delhi

Race Course Club is occupying Govvernment land on temporary lease.

- (b) The details of land rates, terms and conditions including the expiry date of lease deed is given in enclosed Statement (See below)
- (c) and (d) The land rates are notified depending on the utilisation of land. Therefore the same are notified for residential, comercial purposes. For institutional utilisation different set of rates are prescribed depending on the purpose for which land is used. In this particular case, utilisation of land is for club (recreational) and green (open area).

The club is being charged premium at; the rate of 25 percent of the institutional rate of Rs. 39 lakhs per acre per annum plus 2.50 percent of premium as annual ground rent inres-pect of built up area for the period from 1.1.90 to 31.12.94. For green area (open space) the club is being charged annual licence fea (a) Rs. 1000 per acre w.e.f. 1.1.85. These were the rates for covered area and green area applicable to such institutes at that time. The present rate chargeable from such institutions are @ 5 per cent of the institutional rate of Rs. 70 lakh per acre for the covered area and Rs. 5000 p.a. per acre or green area (open space). Details of land rates for the allotted for various purposes by the Ministry are given in the enclosed Statetment-II
