(b) if so, what were the basis for making these allotments on priority and on whose recommendations were these accommodations allotted, giving the names thereof;

(c) the number of allotments made on ad-hoc basis and on seniority basis typewise, area-wise, floorwise during each of the last three years including 1994 so far;

(d) whether any norms of making ad-hoc allotments and the ratio in which these are to be made have been prescribed and if so, what are the details thereof;

(e) whether the norms and the ratio prescribed as such have been followed in letter and spirit and if not, the reasons thereof; and

(f) whether there is any proposal to enquire into the violations made in the ad-hoc allotments and if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI P. K. THUNGON): (a) and (b) Ad-hoc allotment of residential accommodation is done in relaxation of the rules, on medical grounds such as T.B. Cancer, Heart ailment, Physically handicapped etc. and other compassionate grounds. Allotments are made on merits of each case. No statistics of category-wise recommendations made for out-of-turn allotments are maintained.
