### Permission to close sick units

7418. SHRISANJAYDALMIA: Will the Minister of LABOUR be pleased to state:

- (a) whether Government propose to permit sick units to be closed down without resorting to retrenchment by allowing the arrangement of these units to continue with payment of wages to the workers engaged in these units as it is known that the losses incurred in running these sick units is more than the wages being paid to the workers; and

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY (SHRI PABAN SINGH WELFARE GHATOWAR): (a) and(b) Under the Industrial Disputes Act, 1947, an employer who intends to close down an undertaking of an industrial establishment, in which not less than 100 workmen are employed on an average per working day for the preceeding 12 months, shall apply for permission at least 90 days before the date on which the intended closure is to become effective, to the appropriate Government, stating clearly reasons for the intended closure of the undertaking. If permission for closure is granted, every workmen who is employed in the undertaking, shall be entitled to receive compensation under the provisions of the Act. There is no proposal to amend the above provisions of the Industrial Disputes Act.
