Demand for Local Telephone connection between Cuttack and Bhubaneshwar

7460. SHRI BHAGABAN MAJHI: Will the Minister of COMMUNICA-TIONS be pleased to state:

- (a) whether there has been a growing demand for making the STD telephone between Cuttack and Bhubaneshwar local telephone;
- (b) whether Government of Orissa has made a request in that regard; and
- (c) if so, the steps taken to fulfil this demand?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI SUKH RAM): (a) Yes, Sir. Requests in this regard have been received from various quarters.

- (b) Yes, Sir.
- (c) Request of the State Government has been considered. It is not possible to treat STD calls between Cuttack Bhubaneshwar as loal calls under the existing rules because Cuttack and Bhubaneshwar telephone exchange system are situated in separate municipal areas under separate short distance charging areas with their charging centres more than 20 Kms distance apart.

Private participation in Telecom Service

- (a) to what extent telecom services have been privatised;
- (b) whether Government propose to increase private participation in telecom services:

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICA-TIONS (SHRI SUKH RAM): (a) and (b) The Government have decided to involve private sector in supplementing DOT efforts for basic telecom services and also in areas such as Value Added Services.

(c) and (d) For provision of value added services, licences are being issued on application on non-exclusive basic except for cellular & paging services in which case tendering method has been For basic telecom services guidelines are being worked out.

Modernisation of telecom services by Private Sector

- (a) whether Government have drawn up programmes to privatise telecom services:

- (c) and (d) Private sector will be involved to supplement the efforts of DOT for modernisation of telecom services.
