Small Scale Industries, Women & child Development. Health, Development and Civil Supplies and the Director General of Health Services, accompanies by the Secretary to Prime Minister, in April, 1994. As a result of exercises various decisions. including extension of the converge of Revamped Public Distribution System (RPDS) to additional areas in the State; enhancement of outlays under rural development programmes such as, JRY, IRDP, TRYSEM, etc; additional projects under the ICDS; projects in the industrial infrastructure, fruit processing K'VI sectors: assistance and restoration of damaged schools and augmentation of medical and ambulatory services; and enhanced allocation of foodgrains under the PDS system, etc. have been taken. The financial impact of the various decisions taken would be approximately Rs. 152 crores. implementation of these is being closely followed up and monitored in close coordination with the State Government.

(b) and (c) Permanent rehabilitation of the migrants from the Kashmir Valley is not contemplated and it is the effort of the Government to create conditions wherein the migrants can return to their homes in the Valley at the earliest. However, it is not possible to indicate any definite time frame for this prupose.

(b) what are the reasons for the inordinate delay in providing them appointment; and

(c) by when these unfortunate dependents would be given appointment by the C.R.P.F?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS RAJESH PILOT): (a) Applications of the following persons are pending:

- (i) Shri Ariun Thapa. S/o late Const. D.B. Thapa.
- (ii) Shri Rejendra Prasad, S/o late Const. Pati Ram.
- (iii) Shri Pati Ram, brother of late Constable Subash Chand.
- (b) The Candidates could not be offered appointment due to delayed submission applications. of nonsubmission of applications in the prescribed performa. not providing complete documents, processing of the cases by various Authorities and also due to non-availability of vacancies under the compassionate appointment quota.
- (c) the appointment authorities CRPF have been advised to offer appointments to S/Shri Arjun Thapa and Rajendra Prasad immediately. The case of Shri Pati Ram is not covered under the Scheme for compassionate appointment.

Major Initiative to Start Dialogue on Jammu and Kashmir Issue

7783. SHRI JALALUDIN ANSARI: SHRI CHATURANAN MISHRA:

Will HOME the Minister of AFFAIRS be pleased to state:

- (a) whether any favourable situation has been developed recently for a major initiative to start dialogue on Jammu and Kashmir issue: and
 - (b) if so, what are these

developments and steps being taken by Government to start a dialogue utilising this favourable situation?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI RAJESH PILOT): (a) and (b) Even though terrorist violence has continued at a high level, there is a perceptible qualitative change in the situation and in the mood of the people, who appear to be fed up with the continuing mindless violence and the activities of the militants. The effort of the Government is to consolidate on this situation, so that conditions can be created for reactivation of the political process and the democratic institutions, even as sustained pressure is being maintained on the elements. Towards the above end, discussions are being held on a continuing basis with representatives of political groups at the national and State level. Government are not averse to talking with any person or group who is willing to cooperate and contribute towards the restoration of normalcy and peace in the State.

Privatisation of Police Force

7784. SHRI SATISH PRADHAN: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government have approved the privatisation of Police Force in some States, if so, what are the norms adopted for such privatisation;
- (b) which States have been permitted to raise such force;
- (c) whether it is a fact that members of such police force have been issued identity cards through local police officials;
- (d) whether it is also fact that a large number of anti social elements is now holding Police authorisation; and
- (c) what powers are delegated to the private police force?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS

(SHRI P.M. SAYEED) (a) to (e) No Sir. 'Police' is a State subject. As such, the question of the Central Government approving privatisation of police forces in States does not arise. The Central Government is also not aware of any State Government taking up such a proposal, issuing identity cards etc.
