7727. SHRI V. HANUMANTHA RAO: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to slate:

- (a) what are the reasons for the lack of success in combating malaria by Health Ministry;
- (b) whether there is any paucity of funds; and
- (c) if not, whether there is any administrative disability in the Ministry to combat malaria?

THE MINISTER OF HEALTH AND **WELFARE** (SHRI **FAMILY** B. SHANKARANAND) (a) Malaria incidence was brought down from about 6.47 million cases in 1977 to about 2.18 million in 1984. Thereafter, the situation has remained static mainly on account of vector and P. Falciparum resistance to conventional insecticides and drugs respectively.
