Looting of Passengers in Express Trains

7838. **SHRI TINDIVANAM** G. VENKATRAMAN: Will the Minister of RAILWAYS be pleased to state:

- (a) what is the total loss of passengers money and jewellery looted in Express trains during the year 1990, 1991, 1992 and 1993:
- (b) whether the affected passengers have submitted claims in these cases;
- (c) if so, what is the action taken by Government in this regard; and
- (d) if not, what are the reasons therefor?

THE MINISTER OF **RAILWAYS** (SHRI C.K. JAFFER SHARIEF): (a) to (d) 38 claim cases were received for loss of money and jewellery during the year 1990 to 1993.

An amount of Rs. 39,487/- in four cases was restored to the claiments where the money had been received by the Railways as lost or unclaimed properties. However, claim cases amounting to Rs. 13,42,542/- have been repudiated under section 100 of the Railway Act, 1989, because the luggage was not booked and was carried by passengers in their own custody. The Railway is not liable to pay the loss of such unbooked consignments. However, Policing is a State subject and hence maintenance of law and order and control of crime on Railway premises including running trains responsibility is the of the Government concerned, who discharge these duties through the Government Railway Police. The cases of crime on Railways are reported to, registered and investigated by the Government Railway Police.
