(d) Majority of patients with epilepsy have their attacks controlled with drugs and are able to lead reasonably normal life.

Steps to Prevent Polio Among Children

7745. SHRI O.P. KOHLI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether the invisible polio virus strikes more than 40,000 children in India which is 50 per cent of the polio cases in the World;

(b) whether Government would intensify the National Polio Eradication Programme by vaccinating every child below three years of age in a time-bound manner; and

(c) if so, the details of the steps that Government propose to take to check the crippling and debilitating rampant disease among the children by 2000 A.D.?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND): (a) to (c) According to available information 7898 cases of Poliomyelitis were reported globally in 1993. 4077 cases were reported from India. Under the Universal Immunization Programme started in 1985-86 intensive efforts for eradication of poliomyelitis have been undertaken through sustaining high levels of coverage of immunization. The number of reported cases of polio has declined from 28264 in 1987 to 4077 in 1993.
