

Malnutrition among children

2858. DR. NAUNIHAL SINGH:
SHRI RAM RATAN RAM:

Will the Minister of HEALTH FAMILY WELFARE be pleased to state:

(a) whether the problem of malnutrition among children in India is twice as wide-spread as it is in the countries of sub-Saharan Africa;

(b) if so, the reasons thereof;

(c) whether even a state like Kerala has an incidence of acute to moderate malnutrition among children that is worse than what one finds in the countries of the sub-Saharan region;

(d) if so, what are the reasons therefor; and

(e) which state is ahead than others as regards child nutrition and primary education?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. C. SILVER A): (a) A report published by the World Bank indicate higher direct effects but lower indirect effects of malnutrition in India in comparison to sub-Saharan Africa.

(b) The main reasons for incidence of malnutrition among children are high population growth, low per capita income and high incidence of anaemia in women of child bearing age.

(c) to (e) Comparative data are not available.
