- (b) what is being done to see that the ex-servicemen get gainful employment;
- (c) to what extent is the Government of Maharashtra cooperating in this regard;
- (d) whether Government are aware that there is no proper coordination between the agencies of the State and the Central Government; and
- (e) what is being done to see that there is proper coordination in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI MALLIKARJUN): (a) As per available information, as on 31st December, 1993, there were 17,092 ex-servicemen registered for employment assistance with the Zila Sainik Boards in Maharashtra.

- (b) Government have taken various steps to provide gainful employment opportunities to the ex-servicemen. These inter alia comprise reservaion of posts in the Central and the State Governments, Public Sector Uundertakings and Nationalised Banks and relaxation in the prescribed maximum age limits and educational qualifications for appointment of ex-servicemen. A variety of training programmes are conducted for ex-servicemen to improve their employment potential. Several schemes are also in operation to provide assistance to the exservicemen in self-employment ventures.
- (c) The Government of Maharashtra is providing full cooperation in this regard.
- (d) and (e) Proper and full cooperation exists between the agencies of the Central and State Governments.

- (d) Accounts of ordnance factories are audited by the Controller General of Defence Accounts (CGDA) and are also subject to statutory audit by the Comptroler and Auditor General (CAG).
