Internal Promotion Quota in Kendriya Vidyalayas

3446. SHRI N. GIRI PRASAD: Will the RESOURCE Minister of HUMAN DEVELOPMENT be pleased to state:

- (a) whether it is a fact that internal promotion quota earmarked for teaching staff of Kendriya Vidyalayas is 33.3 per sent; and
- (b) if so, What are the details of vacant posts, category-wise that were available for filling through the direct and promotional channels during the current and preceding two sessions as also the details of those which have been filled through promotions during the period referred to above?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) In accordance with the Recruitment Rules, 33-1/3% posts of TGTs & PGT in Kendriya Vidyalayas are filled by promotion from PRTs and TGTs respectively.

(b) No post of TGT and PGT was tilled by direct recruitment during 1991-92 and 1992-93 in respect of General category. However 271 candidates were recommended for appointment; is TGTs and 186 candi-dates as PGTs in special recruitment drive of identified backlog vacancies, for SC/ST in 1992-93. In 1993-94, 1785 and 1554 oilers of appointment have been issued for the post of TGT anl PGT respectively against Direct Recruitment quota.

In all 373 PRTs were promoted as TGT luring 1991-92 and 1992-93. 156 TGTs and 137 TGTs were also promoted to the post of PGT during 1991-92 anl 1992-93 respectively.

Extension of Delhi University

3447. SHRI KRISHNA KUMAR BIRLA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether the Central Government and the University Grants Commission are not paying any adequate attention on the ex pansion and modernisation of the Delhi University;
- (b) whether the number of students seeking enrolment are increasing day by day in the Delhi University;
- (c) whether the plans of setting up more colleges has been pending due to paucity of funds; and
- (d) if so, the concrete steps now the Central Government and UGC propose to take in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT EDUCATION AND DEPARTMENT OF

CULTURE) (KUMARI SELJA): (a) According to the mformatfon furnished by the University Grants Commission besides releasing non-plan maintenance grants to the University of Delhi and its colleges, the Commission has made allocation of Rs. 12.85 crores to the University of Delhi for the 8th plan period for improving the quality and efficiency of departments and faculties by upgrading and modernising the laboratory, library, equipment and workshop facilities and strengthening Central Instrumentaion facilities.

Written Answers

- (b) Yes, Sir. There is a rising trend for seeking enrolment in the University of Delhi.
- (c) The Government of National Capital Territory of Delhi has informed that it proposes to set up three new degree colleges in Delhi and the funds for this purpose Have been provided in its budget for the year 1994-95.
 - (d) Does not arise.

Preservation of Cultural Property

3448. SHRI KRISHNA KUMAR BIRLA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether there is persistent demand to involve private sector in the conservation of cultural property in the country;
- (b) if to, the reaction of Government in this regard;
- (c) whether Government agencies are not able to conserve cultural property in the country; and
- (d) the steps now Government propose to take in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA): (a) to (d) The Government has not received any such demend from public or private Institutions to involve private sector in the conservation of cultural property. However the Government will not be averse to involve any private organisation competent to carry out such conservation. The Indias National Trust for Art and Cultural Heritage and its branches are encouraged to involve themselves in this task. These Oranisations and any other private effort are welcome, not because Government is not able to do these activities but any number of Organisations supplementing efforts in this regard will be to the ultimate benefit of preservation and conserving our priceless Cultural Heritage.
