THE MINISTER OF STATE OF THE MINISTRY OF FOOD (SHRI KALP NATH RAI): (a) to (c) As on 31-3-1994, 231 proposals have been received through the Department of Industrial Development for selling up of new sugar factories in the Cooperative sector in he State of Maharashtra. Of these, 225 applications have been scrutinised by the Screening Committee. After examination, recommendations of the Ministry of Food have been sent to the Ministry of Industry for consideration by the Licensing Committee, after which letters of intent would be issued by that Ministry. The remaining 6 applications are still under consideration in the Ministry of Food. The details of these applications are given in the enclosed statement.
