The Central Government finances generally upto a maximum of Rs. 1 crore for each of the complexes. The balance expenditure and recurring administrative expenditure will have to be borne by the State Government concerned.

(c) The allocation for the scheme during the current year is Rs. 2 crores and so far, an amount of Rs. 80 lakhs has been sanc-*tioaed-for-defray to Governments of Sikkim, Nagaland, West Bengal, Manipur and Madhya Pradesh.

I (d) The scheme provides an integrated complex to facilitate all cultural activities like performing arts, literary activities and exhibitions including libraries and seminar facilities.
