- (d) what was the need and justification for such excessive postings in each case ?

- (d) The teachers in various grades are posted to each Kendriya Vidyalayas generally according to sanctioned strength which is determined each year based on enrolment of the students. If the number of teachers in a particular grade is temporarily m excess because of the change in sanctioned strength or due to postings on administrative grounds they are posted/adjusted as per transfer guidelines in the succeeding years. The teachers in the above schools who are in excess of sanctioned strength are within the overall sanctioned strength of Vidyalayas located in the concerned regions and are to be adjusted/posted during annual transfers as per transfer guidelines.
