  - (i) development of shrimp aquaculture through establishment of Brackishwater Fish Farmers' Development Agencies;
  - (ii) encouraging establishment of integrated shrimp farms and support facilities in the government/public/ private sectors; and
  - (iii) allowing duty free import of shrimp feed.
- (e) An Environmental Impact Assessment Study was made for implementation of a World Bank assisted shrimp culture project.
