

(SMT. BASAVA RAJESWARI) : (a) and (b) A workshop on 'Women and law' was held in New Dehi on 7-8 January, 1994. It was organised by the National Law School of India University, Bangalore to examine the various aspects relating to the Immoral Traffic (Prevention) Act, 1956, Indecent Representation of Women (Prohibition) Act, 1986 and the legal provisions relating to rape. The objective of the workshop was to arrive at recommendations for strengthening the implementation of these laws.

Discrimination of Girls in Education

3470. CHOWDHRY HARI SINGH : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

(a) whether a recent study by "Population Action International" has revealed that India is still amongst the developing countries which discriminate against the girls in the field of education and where the girls take a back seat to boys in access to schooling ;

(b) if so, whether any plan of Action has been or is being proposed to be launched to remove this gender discrimination ; and

(c) if so, the details in this regard ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPTT. OF EDUCATION AND DEPTT. OF CULTURE) (KUMARI SELJA) : (a) to (c) Government has not received any study report by "Population Action International" on girls' education in India. The National Policy on Education (NPE), 1986 as amended in 1992 and Programme of Action (POA), 1992 seek to improve the access of girls to education. The annual growth of enrolment of girls at primary stage during 1980-81 to 1991-92 was 3.7 per cent compared to 2.5 per cent for boys during the same period. In the Total Literacy Campaigns also the enrolment of women is much higher than that of men.
