

### MPs Quota for Seats in Kendriya Vidyalayas

3405. SYED SIBTEY RAZI : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

(a) whether some quota of admission has been provided to M.Ps. and Union Ministers in Kendriya Vidyalayas :

(b) if so, the details thereof ;

(c) whether similar quota has been provided to M.Ps. and Union Ministers in Schools/Vidyalayas either under Central Government or funded by it ; and

(d) if so, the details thereof and if not, the reasons therefor ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) : (a) and

(b) Yes, Sir. A quota of 2 and 5 admissions in Kendriya Vidyalayas in each academic year has been provided for each Member of Parliament and the Union Ministers respectively.

(c) and (d) In the two other school systems run by the Department of Education viz. The Navodaya Vidyalayas and Central Tibetan Schools no similar facility of admissions has been provided to Members of Parliament or Union Ministers. In the Navodaya Vidyalayas, admission is on merit based on an admission test conducted by NCERT and the Tibetan Schools are largely for the children of the Tibetan refugees in India.

### Vacant Posts in Kendriya Vidyalaya Sangathan and Kendriya Vidyalayas

(a) what are the details of total vacancies for direct recruitment and promotees category-wise, available for filling in Kendriya Vidyalayas and Kendriya Vidyalaya Sangathan's regional and headquarter's office for teaching and non-teaching staff during the current academic session ;

(b) what are the details of filling up the same, category-wise, as on date ;

(c) whether promotion quota in respect of each of the categories has been rightly filled up ; and

(d) if so, the details thereof and if not, the reasons therefor ?

THE DEPUTY MINISTER IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT OF EDUCATION AND DEPARTMENT OF CULTURE) (KUMARI SELJA) : (a) to (d) For the teaching posts, the promotion quota is 33-1/3% and direct recruitment is 66-2/3%, except in the case of promotion to the post of Head Master & Vice-Principal, which is filled 100% by departmental

promotion. The direct recruitment upto the post of Trained Graduate Teacher and equivalent cadre is done by the respective Assistant Commissioners. The recruitment for the post of Post Graduate Teacher and above is done centrally by Headquarter Kendriya Vidyalaya Sangathan. A statement indicating the direct/recruitment/departmental promotion vacancies in respect of teaching posts filled up/to be filled during the current academic session is placed as statement-I (See below).

The non-teaching posts are filled up at two levels. The posts of Group 'D' and LDC in Kendriya Vidyalayas are filled by

the respective Principals and by the Assistant Commissioners of the regions respectively. A statement indicating the vacancies filled/to be filled by direct recruitment/departmental promotion in respect of non-teaching posts, on which action has been taken by the Headquarter Kendriya Vidyalaya Sangathan is placed a statement-II. (See below). Holding of Departmental Promotion Committees and Selection Committees for Direct Recruitment is a continuous process. Kendriya Vidyalaya Sangathan is following the instructions issued by the Department of Personnel in filling up the Departmental Promotion and Direct Recruitment vacancies as per roster.
