(b) and (c) According to the information furnished by IGNOU, the University has not developed any laboratory facilities so

far for any experimental work for science students. Further, the first cycle of the B. Sc. Programme has not yet been completed, the said Programme having been launched in 1991-92. In the circumstances, the University has no proposal at present to introduce Master's Degree Programme in Science subjects.
